Madam/Sir,

Please refer our E-tender with Ref. No. AAI /BM/TECH/Utility Vehicle Hiring/2020/01 with Tender ID No. 2020_AAI_42116_1 towards "Hiring of One number of Utility vehicle for Engineering Section at Belagavi Airport".

The Airport Director, Airports Authority of India (AAI), Belagavi Airport has approved your offer as per your quoted rates in E-Tender. The **approved rate for monthly hire charges is Rs. 13250/- plus applicable GST**, and Rs. 9.00/- per KM for extra KMs beyond 1500 KMs per month and Rs.100.00 per Hour for extra Hours beyond 08 Hours a day, 6 Days a week. **The total amount for 24 (Twenty Four) months will be Rs. 10, 38,000/- (Rupees Ten lakh thirty eight thousand only) plus applicable GST.**

The approved rates and mileage details, etc. are mentioned in "ANNEXURE-A"

The following terms and conditions shall apply:

1. The contract shall commence **with effect from 01.05.2020 at 00:00 Hrs** for a period of 24 (twenty four) months.
2. All Terms and conditions as mentioned in the Tender document (TENDER ID No. 2020_AAI_42116_1) must be complied.
3. Contractor should provide the vehicle of 2017 onwards model at the time of deployment. The vehicle shall be with commercial registration with current Insurance and related documents. Any vehicle which may primarily be meeting the above age norms but the same if not found to be in good mechanical and physical condition, having dirt/bad

exteriors or interiors, vehicle with peeled off paint, scratches, dents on the body, torn/dirty seat covers etc., will not be accepted. Vehicle should be cleaned hygienically and well maintained at all times.

4. The Airport Entry Permit (AEP), Airside Driving Permit (ADP) for vehicles and drivers operating vehicle must be timely taken. Security parameters must be strictly followed.
5. The Driver shall compulsorily wear uniform with name badge displayed and should be well-mannered, neat and tidy in all respects; he should also carry personal mobile phone.
6. **The Junior Executive (Technical)/Technical In-charge, AAI, Belagavi Airport, shall be the Officer-in-charge of the work. The contractor shall execute the contract agreement on a non-judicial stamp of value of Rs.100/- within 30 days from the date of issue of this work order and the cost of the stamp paper shall be borne by the contractor.**
7. As per the terms and conditions mentioned in the NIQ, the contractor shall deposit an amount of Rs. 141226/- (Rupees one lakh forty one thousand two hundred twenty six only) towards Security Deposit (after adjustment of EMD amount) by way of demand draft in favour of "Airports Authority Of India" drawn on any scheduled/nationalized bank payable at Chennai or by submitting bank guarantee in AAI's format from a Nationalized / Scheduled Bank (But not from co-operative or Gramin Bank). The Security Deposit/Bank guarantee shall be submitted within 30 calendar days from the issue of this Award Letter and will be valid till 90 days after the end of the expiry of the contract, failing which, the same shall be deducted @10% of the gross amount of each running bill till the total security deposit amount is recovered. No interest on or any other expense whatsoever, on security deposit is payable by AAI.
8. As per the declaration given in the NIT process, the Contractor is required to register with appropriate EPFO and ESIC Registration authority and deposit their EPFO and ESIC registration certificate with AAI.
9. Starting KMs shall be counted from the respective user reporting place only. The vehicle shall be deployed at the Engineering Office, AAI, Belagavi Airport. The driver must ensure that the log book of the vehicle is duly filled in all respect after each trip. The log book must be closed every day duly mentioning the km run per day and countersigned by the corresponding user. The driver should report to **Jr. Executive (Technical)/Technical In-charge** for verification of the log book.
10. The Contractor must name his liaison officer/representative to be available for coordination in connection with day-to-day running of the vehicle.
11. The contractor shall take prior permission of AAI for substitution of any vehicle in case of Breakdown/maintenance.

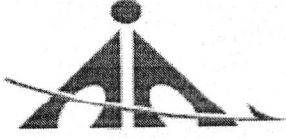
