Subject :- - Supply of GYM equipments for fire section at Kullu Manali Airport.

It was found that total 03 bidders have submitted their Qualifying technical documents. After technical scrutiny of papers submitted by the each bidders, the following observation has noted in respect of each of the bidders.

1. **M/s Power House Sports, Delhi:** The agency has submitted work experience along with work order no. IAA/AGM(EF)/GYM/2019-20/652, Dtd..17.10.2019 but BOQ of work order has not submitted, Proof of turnover (Abridged balance sheet along with profit & loss account for FY 2016-17, 2017-2018 & 2018-19 of the firm and detail of T & P list as per work requirement as per e-NIT Criteria.

The agency requested to upload work experience certificate along work order & BOQ of similar nature of work (In case experience of Private Clients, TDS certificate from clients to be enclosed) or valid registration certificate in appropriate class, , Proof of turnover (Abridged balance sheet along with profit & loss account for FY 2016-17, 2017-2018 & 2018-19 of the firm and detail of T & P list as per work requirement as per e-NIT for pre qualifications only latest by 1200 hrs. Of 20.02.2020 in short fall folder at CPP portal failing which bid shall not be considered further.

2. **M/s Maruti Trade India, Kolkata:** The agency not submitted Proof of turnover (Abridged balance sheet along with profit & loss account for FY 2016-17, 2017-2018 & 2018-19 of the firm and detail of T & P list as per work requirement and duly notarized declaration on non judicial stamp paper of Rs. 100/ regarding black listing/ debarring of firms from AAI or State & central govt. as per e-NIT.

PR 143, and Undertaking of Registration / Experience Certificate as per Annexure-4 at page no. 144 on company letter head as per e-NIT for pre qualifications only latest by 1200 hrs. Of 20.02.2020 in short fall folder at CPP portal failing which bid shall not be considered further.
