

Subject- providing security Guard and allied services at AAI, Gaya airport under DGR Sponsorship.

Evaluation of Technical BID

Date- 18/03/2020

On the basis of Evaluation of technical Bid on above subject on dated 05/03/2020 by the committee, following short fall were asked from following three companies –

- 1) M/S 5311 Kanwaljit Singh Security agency- Short fall asked – Form 5 A and Labour license
- 2) M/S 5390 B Amarnath Reddy Security Agency- Short fall asked - Form 5 A and Labour License.
- 3) M/S 3229 Rajeev Ranjan security agency- Short fall asked - Labour license.

Tender for short fall was opened on 16/03/2020 and on the basis of documents submitted by the above agencies, following are the observations-

- 1) None of the agency have submitted the Labour license. However, Agencies have submitted form iii (Registration of establishments)
- 2) Form 5 A could not be submitted by M/S 5311 Kanwaljit Singh SA and M/S 5390 B Amarnath Reddy how ever they have submitted their EPF registration certificate.

As per "Contract Labour (Regulation and Abolition) Central Rules, 1971", for registration of the establishment, form iii (rule 18-3) is required. However for labour license application, the details of Principal employer is needed by the agency in form IV.

As per DGR letter no. 28(03)2012/D(Res-1) dated 09/07/2012 clause 13 – **Labour licence-** "The security agency will also obtain a labour license for provision of contract labour in accordance with the government order on the subject. The labour license can be obtain from the office of the concerned central labour department office in the state."

Hence labour license may be asked from L-1 agency after award of the work. This will not effect the sanctity of the limited tender as equal opportunity is being given to all the agencies.

In view of the above and documents submitted by all 04 DGR sponsored security agencies - as M/S 4509 Devashish singh security Agency, M/S 5311 Kanwaljit Singh Security Agency, M/S 5390 B. Amaranatha Reddy Security Agency, M/S Rajeev Ranjan security Agency, technical Bid of M/S 5311 Kanwaljit Singh Security Agency, M/S 5390 B. Amaranatha Reddy Security Agency, M/S Rajeev Ranjan security Agency may be accepted and Technical Bid of M/S 4509 Devashish Singh security agency may be rejected due to expiry of their DGR empanelment certificate.

It is proposed to open financial bid on 20/03/2020 at 1600 IST as the validity of present sponsorship of DGR is expiring on 23/03/2020.
