1. This is with reference to your "Technical & Financial bid along with other documents" referred above in connection with our Tender No. AAI/CHQ/ITD/checkpoint/2020 titled as "Comprehensive Annual Maintenance Contract and Renewal of Licenses & Support for Checkpoint Firewall for 1 Year".
2. Your offer as mentioned above for supply of services as per bill of material & financial details given in Annexure I to this letter has been accepted for and on behalf of the Chairman Airports Authority of India.

3. PRICE & PERIOD OF CONTRACT

- 3.1 The items in Annexure-I shall be delivered at total cost of INR. 4245000/- (Forty Two lakhs Forty Five thousand only) . The prices are exclusive of GST.
- 3.2 The contract shall commence from "Date of Support of services/Renewal of Licenses of respective devices to AAI Data Centre" at AAI site.
- 3.3 "Period of Contract" shall be initially for one year from the Date of Support of services/Renewal of Licenses of respective devices to AAI Data Centre, it can be further extended to another 1 year on satisfactory services based upon site requirements under the same terms and conditions. However, AAI reserves the right to terminate the contract by giving 30 days' advance notice without assigning any reason thereof.
- 3.4 The effective start date of the contract will be 01/04/2020
