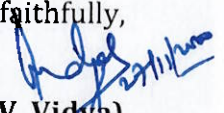

1. Your E-tender for the work mentioned above is hereby accepted on behalf of Chairman, Airports Authority of India at the Lump-sum rates negotiated by you totaling to **Rs.10,21,91,996/-** (Rupees Ten Crore Twenty One Lakh Ninety One Thousand Nine Hundred & Ninety Six Only) inclusive of all taxes except applicable GST which shall be paid extra as per actual.
2. **Coördination In-Charge (CIC)** of Jpint Venture Monitoring Unit (JVMU) at Sardar Vallabhbhai Patel International Airport shall be the Officer-in-charge of the work. You are requested to attend the office of **General Manager (Fin.)-JVC/Tariff Cell** by **07.12.2020** to sign and complete the contract agreement. The contract agreement shall be executed on a non-judicial stamp paper of value **Rs.100/-** (Rupees One Hundred only) and the cost of the stamp paper shall be borne by you.
3. The earnest money amount of **Rs. 5,00,000/-** (Rupees Five Lakhs Only) received along with your tender will be treated and converted as part of Security Deposit as per Clause No. 2 on page no. 19 of tender document. Please deposit **Rs. 46,09,600/-** (Rupees Forty Six Lakhs Nine Thousand Six Hundred Only) towards **Security Deposit** within **10 days** from the date of issue of this letter, failing which, the same will be deducted from your running bills as per terms & conditions of contract document.
4. Within **30 days** of issue of award letter, you shall submit to AAI, a **Performance Guarantee** as per condition of Clause 3 on page no. 19 for an amount of **Rs.51,09,600.00** (Rupees Fifty One Lakh Nine Thousand Six Hundred Only) in the form of Bank Guarantee on the Proforma appended at Annexure 2A on page-59 of tender document.

5. You are requested to comply with the provision of Contract labour (Regulation and Abolition) Act 1970 and Contract labour (Regulation and Abolition) Central rules 1971, Child Labour (Prohibition & Regulation) Act 1986, Construction Workers (Regulation of Employment and Condition of Service) Act 1996, Building and other Construction Workers Welfare Cess Act 1996 and minimum wages act and rules thereof central and state Governments.
6. You are also directed to contact **Coordination In-Charge (CIC)** of Joint Venture Monitoring Unit (JVMU) at Sardar Vallabhbhai Patel International Airport immediately who will be the nodal officer for this work.
7. Please note that the time allowed for carrying out the work shall be **36 Months** and same shall be reckoned from the **10th day** after issue of this letter.
8. Any further correspondence in connection with the contract should normally be addressed to the **Joint General Manager (Engg.-C)-JVC**, Airports Authority of India, Room No. 270, 2nd Floor, C-Block, Rajiv Gandhi Bhawan, Safdarjung Airport, New Delhi-110003.
9. The payment shall be governed as per the payment terms mentioned in clause 14 & 16 of General Conditions of Contract of the tender document.
10. In terms of Clause 24.3.1 of Concession Agreement and Clause 5 of Notice Inviting e-Tender conditions, the Concessionaire **Adani Ahmedabad International Airport Limited (AAIAL)** shall bear the cost associated with the appointment of Independent Engineer. EPIL shall raise the bill on quarterly basis to AAI duly certified by Authorized Signatory of Independent Engineer and endorsed by **Airport in-charge of Concessionaire (AAIAL)**.
