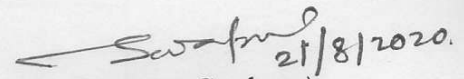

The earnest money (DD against EMD) amount of Rs.2,97,308/- (Rupees Two Lakh Ninety Seven Thousand Three Hundred Eight only) received along with your tender will be treated and converted as part of Security Deposit as per condition of clause no.1A on page 16 of the contract document. Please deposit Rs.6,48,472/- (Rupees Six Lakh Forty eight Thousand Four Hundred Seventy Two only) towards security deposit within 10 days from the date of issue of this letter failing which, the same shall be deducted as per condition of clause no. 1A at GCC page no. 16 of the contract document.

6. Please note that the time allowed for the work shall be 02 (Two) Years and same shall be reckoned from 01.09.2020.
