1 Period of Contract

2 Termination of services

The engagement of Consultant can be terminated by the Management of Airports Authority of India without assigning any reason, whatsoever, at any time during the contract period by giving 30 days' notice.

3 Confidentiality Clause

Any and all information in written, electronic media or oral form and disclosed to the Consultant shall at all times remain the legal and absolute property of AAI and the Consultant shall have no rights to use the information for any purpose other than that expressly authorized by AAI. Consultant has to **sign a Non-disclosure Agreement as per proforma given in Format – V of EOI on letter head and submit to AAI along with acceptance of this PO.**

4 Price

- a. The lumpsum price in Indian Rupees for Issuance of Installation Certificate for ANS equipment's is INR 4000.00 per case. (Rupees Four Thousand only per case).
- b. The price shall be firm and inclusive of all applicable taxes & duties except GST. GST will be paid as per applicable rate at the time of payment.
- c. The above price includes all expenses including travelling, boarding, conveyance & other miscellaneous and out of pocket expenditure.

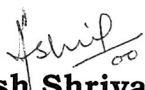
5 Payment Terms

- c. The payment will be made by electronic transfer.
