Reference is made to your bid against above referred tender. In this regard the Airport Director, Calicut International Airport on behalf of Airports Authority of India is pleased to place Work order for AMC FOR AOCC OPERATION AND FIDS DATA ENTRY AT CALICUT INTERNATIONAL AIRPORT, for an amount not exceeding Rs. 1153699 (Rupees Eleven Lakh Fifty Three Thousand Six Hundred and Ninety Nine only) plus applicable GST by **deploying 5 Skilled labours as per Tender conditions** and as per the terms and conditions mentioned below. The payments and expenses for obtaining Airport Entry passes deployed by the agency has to borne by the Agency.

Terms and conditions

1) Payment Terms:

As per the BOQ submitted by the Bidder the amount payable is Rs. 1153699.00 (Rupees Eleven Lakh Fifty Three Thousand Six Hundred and Ninety Nine only) plus applicable GST by **deploying 5 Skilled labours as per Tender conditions**.

CAMC Payment will be made on completion each Quarter on production of the following documents **as per the terms and conditions in the Tender document**

- 1) Two copies of Duly signed Bill/ Invoice
- 2) Relevant page of Bank Passbook copy of the employees for confirming the minimum wages and prorate Bonus payment to the Employees.

3) Proof of ESIC payment for each employee.

4) Proof EPF payment for each Employee.

5) Certificate from the Unit Incharge/ Nominated AAI Official that the work completed satisfactorily.

2) Labour rules:

a) The salary payment to the Employees by the contractors should be made through cheques / NEFT only. The copy of the Bank transaction statement regarding this may be produced. The authenticity of these Bank statements, the minimum wages and minimum bonus will be verified by AAI official before clearing the Bill. The proportionate minimum Bonus has to be paid to Employees along with monthly Salary. The Salary to the Employees should be made before 7th of every month.

b) The time to time increase in the minimum wages after commencement of AMC will be borne by AAI provided it is claimed by the contractor with the supporting documents/ Ministry order, by considering the minimum wages at the time of AMC commencement as the base value. No increase in the Profit margin to the contractor will be permissible.

c) All statutory payment such as EPF, ESIC, Yearly Bonus as per prevailing rules are to be paid by the contractor on regular monthly basis and the actual amounts can be reimbursed as supplementary bills along with the quarterly bills on production of proper documentary proof.

The receipt for payment towards EPF and ESI for the Employees should be submitted. The E payment receipt of EPF and ESIC should be verified from the EPFO site online by the Unit In charge and certified.

3) Security Deposit:

Bank Guarantee may be submitted for 10% of the CAMC Tender amount from a nationalized bank valid for 6 months after the end of the period of contract. Performance Bank Guarantee shall be submitted within 30 Days of acceptance of work order.

4) Paying Authority :

Airport Director, Airports Authority of India, Calicut International Airport, Calicut Airport (PO), Malappuram Dist, PIN-673 647. Payment will be made through e-payment only. Bank A/c details certified by the bank authorities in the format given in Tender , may please be attached along with the bill for payment action.

5) Tenure of CAMC:

One year from 01/10/2020 and extendable for one more year if required by AAI.

6) Acceptance of Contract & Signing of Contract Agreement.

You have to forward your acceptance of the work order by signing at each page of this purchase order and return to AAI within **seven working** days for confirmation and also to execute an agreement on Rs.200/- Non-judicial stamp paper within **three weeks** of the placement of this purchase order Format is attached.

7) Contract Monitoring:

Airport system Unit In Charge, who is the authorized representative of the competent Authority, shall be the work- In- Charge, who will carry out technical inspection/ monitor performance of this contract.

8) Penalties

The serviceability of all the FIDS displays should be maintained more than 95% on all days 24 hours and arrangement should be made for attending the displays in case of any fault without delay as per the condition of the contract. If it is found that the serviceability is below 95% due to failure of data entry on the part of the operator, penalty @ 10% of the bill for that period will be imposed. In addition to that, the contractor will be penalized for the poor maintenance as follows:

Absence of data entry operator

Rs 1000/= per day will be charged if the operator is found absent that particular day.

For unattended data entry work

Actual cost incurred to the department will be levied in addition to the penalty clause mentioned above.

Any complaint which directly or indirectly disturb or affect the normal operation or cause direct or indirect difficulty or discomfort to the office or airlines operators or any other agency involved in air traffic operation. All critical complaints have to be attended and rectified within two hours from the time of reporting of the complaint, failing which a penalty at the rate of Rs 500/- per hour will be recovered subject to a maximum of Rs 2000/- per day.

The contractor will be required to depute sufficient skilled persons for the data entry of FIDS

Regarding the categorization of complaint, the decision of Engineer in charge will be final and binding on the contractor.

For not paying the wages of employees on time:

The contractor has to pay the wages of the employees by 7th of coming month without fail. If due to any unseen circumstances, the payment is delayed, it should be intimated to the CNS Incharge and get approval in advance. In the case of any delay beyond the time of payment without approval from the concerned authority, a penalty of Rs 200/- per

You are requested to furnish the contact numbers, Name and Educational Qualification of the persons employed for CAMC work as per the Tender document.

All other Terms and conditions shall be as per the Tender Conditions.
