3. The earnest money amount of **Rs. 1,07,970/- (Rs. One Lac Seven Thousand Nine Hundred & Seventy Only)** received by **D.D. No.- 503055 Dt. 02.07.2020** issued by **ICICI Bank, Gwalior, Morar** along with your tender will be treated and converted as part of Security deposit as per condition of clause no. 18 on page NIT-3 of contract document. Please deposit **Rs. 3,29,035/- (Rs. Three Lac Twenty Nine Thousand & Thirty Five Only)** towards Security deposit within **10 days** from the date of issue of this letter, failing which, the same will be deducted from your running bills as per terms & conditions of contract document.
4. You are requested to comply with the provision of contract labour (Regulation and abolition) Act 1970 and contract labour (Regulation and Abolition) central rules 1971 and minimum wages act and rules thereof central and state Governments.
5. You are also directed to contact **Manager Engg.(E)II- IMU** immediately who will arrange to hand over the site to you.
6. Please note that the time allowed for carrying out the work shall be **24 Months** which shall be reckoned from the **01.08.2020**

7. Any further correspondence in connection with the contract should normally be addressed to the **Joint General Manager Engg.(E)-IMU**, AAI, Rajiv Gandhi Bhawan Safdarjung Airport, New Delhi-03.
8. Ten percent of total value of work done shall be deducted as security deposit from the bill. Any other deductions as per govt. guidelines will be done.
9. You will be responsible to make good and remedy at your own expense of any defect which may develop or may be noticed within the defects liability period which shall be reckoned **06(Six) Months** from the certified date of completion. The security deposit shall be refunded after expiry of defects liability period.
10. Please acknowledge the receipt of the letter and return the duplicate copy of this letter enclosed herewith after sign as a taken of acceptance.
11. This work order is allowed the number **AAI/CHQ/IMU/ AGME(E)-II/WO-03/2020-21** Dt. **30.07.2020** which be quoted by you for all future correspondence in connection with this work order.
12. All the letters referred shall from the part of Contract agreement.
13. In case of non- compliance of GST provisions and blockage of any input credit, it shall be your responsibility to indemnify AAI.
14. The rates are inclusive of all taxes but excluding of GST. **However GST, as applicable, shall be paid to the contractor for any taxable Supply /services/construction rendered by the agency to AAI against a valid GST invoice as per terms and conditions of the contract and no additional amount such as contractor's overhead and profit will be paid on this account.**
15. All input credits will be passed on to AAI by you.
