Sir,

1. Your offer for the work mentioned above is hereby accepted on behalf of Chairman, Airports Authority of India at the item rates quoted by you totalling to Rs 2,83,107.6/- (excluding GST) for 12 Months period.
2. DGM (Ops.), AAI, Ahmedabad shall be officer in-charge for this work. You are requested to depute your accredited representative, empowered to sign the contract agreement on your behalf to attend the office of the DGM (Ops.), AAI, Ahmedabad within 15 days of the commencement of the work. The contract agreement shall be executed on a non-judicial stamp paper (Gujarat) of appropriate value and the cost of the stamp paper shall be borne by you.
3. Please deposit Rs 28,310/- (Rupees Twenty Eight Thousand Three Hundred Ten Only) towards Security Deposit within 15 days from the date of issue of this letter, failing which the same will be deducted from your running bills as per Schedule "A" (iii) of the Tender Document. Security deposit will also be accepted in form of Fixed Deposit Receipts / Bank Guarantee of Nationalized Bank or any Scheduled Bank but not from co-operative or Gramin Bank in accordance with the prescribed form, provided confirmatory advice is enclosed.
4. You are requested to comply with the provisions of contract labour (Regulation & Abolition) Act 1970 and contract labour (Regulation & Abolition) central rules 1971 & minimum wages act and rules thereof and other applicable rules & regulations as amended from time to time.
5. You are directed to give the details of the Skilled Technician as per clause 24 of schedule A, who will look after the work at Ahmedabad airport. He may be directed to contact DGM (Ops.) or his authorized representative immediately who will arrange to hand over the site for the execution of work.
6. Please note that the time allowed for carrying out the work shall be 12 Months and the same shall be reckoned from 20.10.2020 or handing over of site whichever is later.
7. The tool, plants and machinery required for the smooth execution of the work as per site requirement is to be arranged by the agency at his own expenses. Nothing extra shall be paid on this account.
8. AAI have the right to increase / decrease the scope of the work as specified in tender i.e. the area of disinfections etc. The instruction of Airport Director or his authorized representative shall be final and binding on the agency. The payment / recoveries shall be made to the agency as per quoted rates on pro-rata basis.

9. Any further correspondence in connection with the contract should normally be addressed to the DGM (Ops.) o/o Airport Director, AAI, SVPI Airport, Ahmedabad.

10. Novation Clause:

The contract period is 12 months or the date of transfer of the airport under the PPP mode/ O&M contract. The contract may be terminated with a termination notice of 15 days without any liabilities to AAI on account of anything else what so ever.

Obligations relating to Transfer

The Authority agrees that during the Contract Period, in the event the Authority transfers the rights to operate and maintain the Airport to a third party(s), the Authority shall ensure that;

The Authority shall cause to transfer/novate this Agreement, in favour of such third party, on the principle that such transfer/novation would release Authority of all liabilities and obligations arising from and after the date of transfer/novation of such rights. The Parties, along with relevant third party(s) shall execute necessary documentation or put in place necessary agreements for the aforesaid transfer/novation;

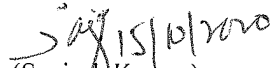

The rights and obligations under or pursuant to all contracts and other arrangements entered into in accordance with the provisions of this Agreement between Authority and Contractor shall be vested in such third party.

11. All Terms & conditions of NIT /Tender document will apply.
