

SHORT FALL SCRUTINY OF ENVELOPE -I

Subject :- -Providing services of one number driver for Airport Director vehicle for two years (2020-2022) on contract basis including all Saturday and Sunday at Kullu Manali Airport, Bhuntar.

For the above work e-bid was created on date 16.09.2020 with Tender ID 2020_AAI_57684_1. A committee of 03 members was created for the process of tendering and following are the members of committee.

Envelope-I was opened on 29.09.2019 at 15:35 PM by Sh. Naresh Kumar, Manager (Engg-Elect), Kullu Manali Airport & Sh. Nitin Verma, AM (Finance), RHQ-NR, Rangpuri, Delhi. It was found that total 06 bidders have submitted their Qualifying technical documents. After technical scrutiny of papers submitted by the each bidders, the following observation has noted in respect of each of the bidders.

1. **M/s Singh Associates, New Delhi- 110077:** The agency has not submitted work completion Certificate along with work order of similar nature of work, Proof of turnover (Abridged balance sheet along with profit & loss account for FY 2019-20 or certificate of net worth from chartered accountant as per annexure-VI format (PR-8) of the firm and Scanned copy of regarding minimum wages on Rs. 100/ Non Judicial Stamp Paper as per annexure-V as per e-NIT Criteria.

The agency requested to upload work experience certificate along with work order of similar nature of work (In case experience of Private Clients, TDS certificate from clients to be enclosed), Proof of turnover (Abridged balance sheet along with profit & loss account for FY 2019-20 or certificate of net worth from chartered accountant as per annexure-VI format (PR-8) of the firm and Scanned copy of regarding minimum wages on Rs. 100/ Non Judicial Stamp Paper as per annexure-V as per e-NIT for pre qualifications only latest by 1500 hrs. of 08.10.2020 in short fall folder at CPP portal failing which bid shall not be considered further.

2. 3. M/s Corporate Care, Shimla- 171009, (HP). The agency has not submitted Scanned copy of letter regarding minimum wages on Rs. 100/ Non Judicial Stamp Paper as per annexure-V, scanned copy of AAI acceptance letter as per annexure-I and check list in proper way as per e-NIT.

4. M/s R.K. & Company, District Hamirpur (HP). The agency has not Proof of turnover (Abridged balance sheet along with profit & loss account for 2019- 20 of the firm or certificate of net worth from chartered accountant as per annexure-VI format (PR-8), Scanned copy of regarding minimum wages on Rs. 100/ Non Judicial Stamp Paper as per annexure-V, Scanned copy of letter regarding black listing/ debarring of firms as per annexure-IV and check list in proper way as per e-NIT Criteria.

The agency requested to upload Proof of turnover (Abridged balance sheet along with profit & loss account for 2019- 20 of the firm or certificate of net worth from chartered accountant as per annexure-VI format (PR-8), Scanned copy of letter regarding minimum wages on Rs. 100/ Non Judicial Stamp Paper as per annexure-V, Scanned copy of letter regarding black listing/ debarring of firms as per annexure-IV and check list as per e-NIT for pre qualifications only latest by 1500 hrs. of 08.10.2020 in short fall folder at CPP portal failing which bid shall not be considered further.

- 5 **M/s Kesari Workers, Allahabad:** The agency has submitted MSME Certificate in manufacturing category to exemption for Tender fee & EMD but as per e-NIT Criteria Services category MSME certificate is required. The agency has not submitted work experience certificate along with work order, ESIC registration certificate and Check list in proper way as per e-NIT.

The agency requested to upload valid MSME certificate of services category to exemption of tender fee & EMD, work experience certificate along with work order of similar nature of work (In case experience of Private Clients, TDS certificate from clients to be enclosed) ESIC registration certificate and complete filled check list as per e-NIT for pre qualifications only latest by 1500 hrs. of 08.10.2020 in short fall folder at CPP portal failing which bid shall not be considered further.

6. It was found that M/s Escort Services, Meerut has submitted all documents of envelope -I as per e- NIT criteria and found eligible for opening of Envelope -II.
