In this regard it is intimated that your offer for award of **operating Snack Bar in SHA inside Terminal Building at Dehradun Airport** has been accepted by the Competent Authority with following terms and conditions:-

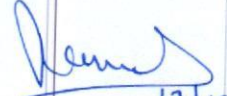
1. The period of concession shall be 01 (one) year further extendable upto 06 (six) months.
2. Licence fee and other charges shall be payable as under:-
 - (i) Monthly License fee of **Rs. 4,70,788/- (Rupees Four Lakh Seventy Thousand Seven Hundred and Eighty Eight only); + (plus)**
 - (ii) Utility/ Facilitation Charges at 10% of normal space rent (or as may be notified by AAI from time to time, presently normal notified A/c space rent is Rs. 1015/- Per Sqm per month subject to annual escalation of 10%, rounded off nearest to Rs.5/- w.e.f. 1st April of every year or as decided by AAI from time to time; + **(plus)**)
 - (iii) All Government Taxes including GST at applicable rates notified by Government of India/State Government/UT from time to time;
3. In addition to above, charges towards consumption of electricity and water, as may be notified/directed by the Authority and at the rate(s) notified from time to time are payable.

4. One month advance license fee along with 10% Utility Charges (for 10 sqm-approx), i.e., **Rs. 4,71,803/-** (Rs.4,70,788/- + Rs.1015/-) (**Rupees Four Lakh Seventy One Thousand Eight and Three only**) plus **Rs.84,925/-** (**Rupees Eighty Four Thousand Nine Hundred and Twenty Five only**) as GST@18% is payable in the form of NEFT/ RTGS in favour of Airports Authority of India at Dehradun **within 15 days** from the date of the award letter.
5. (i) Payment of Security Deposit equal 03 (three) months of Licence Fee, i.e., **Rs.14,12,364/-** (**Rupees Fourteen Lakh Twelve Thousand Three Hundred and Sixty Four only**) in the form of NEFT/RTGS or BG from a Nationalized / Scheduled bank, **valid upto 06 (six) months** after the expiry of Licence period, in favour of Airports Authority of India at Dehradun Airport **within 15 days** from the date of issue of award letter.
- (ii) Payment of Security Deposit equivalent to 5% of annual licenece/concession fee, i.e. **Rs. 2,82,473/-** (**Rupees Two Lakh Eighty Two Thousand Four Hundred and Seventy Three only**) is to be submitted for electricity/ water/telephone etc. in the form of NEFT/RTGS or BG from a Nationalized/Scheduled bank, **valid upto 06 (six) months** after the expiry of Licence period, in favour of Airports Authority of India at Dehradun Airport **within 15 days** from the date of the issue of award letter.
- (iii) Please refer to Clause 13 (h) of NIET for Bank details for the purpose of above payments.
- (iv) No interest is payable on security deposit.
- (v) Details of contract person, Contact Number and Email Id, where the bills to be forwarded, may be provided to this office.
6. Agreement on a Non-Judicial Stamp Paper with denomination of Rs.100/- is to be executed within gestation period from date of issue of award letter.
7. The necessary Airport Entry Permits to the authorized representative(s) and employees of the concessionaire shall be issued by Airport Director as per rules/regulations of BCAS. It shall be responsibility of the Licensee to obtain character verification and other relevant documents for this purpose.
8. This Award letter along with other clauses of NIT shall be the part of the Agreement.
9. All other terms and conditions shall be applicable as per other Clauses of NIT.
10. In case of increase in the counter space in NTB (while shifting as per NIT), the Licence Fee may be increased while keeping in mind the following factors :-



- a) Notified space rental at Dehradun Airport
 - b) Growth in passenger movement
 - c) Increase in business potential
11. The decision of Authority for increase in Licence Fee shall be final and binding on the prospective Concessionaire/Licensee.

You are requested to convey your acceptance along with copy of this Award letter (duly signed by the licensee) within 10 days of issue of the award letter and to complete other formalities as per para 4, 5 & 6 failing which the EMD shall be forfeited and licensee will be debarred from participating in any tender of AAI for one year.
