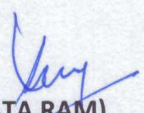

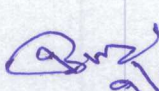
The estimated cost of the tender was Rs. **37,39,923/-**.

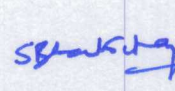
After opening of Technical bid all the participants were found to be technically qualified but after opening of Financial Bid, it has been observed that one bidder has submitted bid which is 99.95% below of the estimated amount. As per Para 7.12.1.2 of "Manual for procurement of Goods & Services 2018", justification was asked from bidder for quoting such low price. In reply to the same, the bidder intimated that he has quoted the value wrongly and submitted another quote. In view of the above, the committee is in the view that :-

1. "Manual for procurement of Goods and Services 2018" is silent on issues pertaining these type of cases.
2. L-1 bidder has informed that he has submitted the bid by mistake and re-submitted a new quote. new Quote is not L-1 quote so a new company becomes L-1.
3. As per NIT, there is no provision of converting L-2 to L-1 as per CPP Portal.

Hence, the committee hereby proposes to cancel the tender.
