Subject: License for operating Tea/Snack bar, Vehicle Parking Management Rights, Trolley advertisement rights cum retrieval and Airport Entry Ticket at Mysore Airport - recommendation for approval of award of single tender - Reg.

Brief of the case:

Reference is made to following points:

- 1) Initial LCAC meeting held on 29.06.2020 for recommendation of MRLF for an amount of **RS. 1,10,100.00** per month for tender action.

Accordingly Tender vide. 2020_AAI_56185_1 on 27.08.2020 was called through CPPP, which was approved by APD. The tender has been auto extended twice owing to NIL participation from prospective bidders. It is to be noted that despite having extended the tender twice, it had attracted no response.

Hence, cancelled the tender for operating combined contract for **Tea/Snack bar, Vehicle Parking Management Rights, Trolley advertisement rights cum retrieval and Airport Entry Ticket at Mysore Airport.**

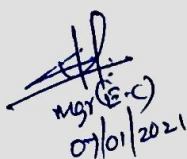
- In view of the above tender action and no response received even after auto extension, and also considering the present scenario of post COVID 19 pandemic situation owing to decrease in PAX movement compared to previous year, it is proposed for revision in MRLF downward to 30% in reference to clause 7.3.3 of commercial manual.

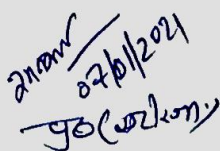
Considering the above said facts and present pandemic situation, it is proposed to fix the MRLF of **Rs. 77,070.00 per month** for recall of tender. (Which is 30% below the previous MRLF)

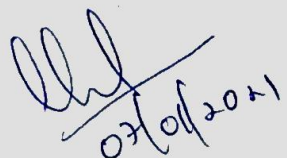
Hence, LCAC recommended the MRLF of **Rs. 77,070.00 per month** plus applicable GST + utility charges and obtained approval for the same from competent authority.

Accordingly tender vide 2020_AAI_61512_1 on 05.11.2020 was called through CPPP for which received two bidders participation out of which one has been disqualified in the technical scrutiny due to debarment vide letter AAI/PAT/COMML/Meet&Greet/323, dtd:01.12.2020. Hence, out of two bidders, only one party the qualified for financial bid opening and henceforth, this is considered as single tender.

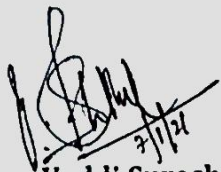

- As per DOP 5.4 (b), with the approval of competent authority RED, SR financial bid of single tender was opened. The single bidder M/s SV & Sons has become H1 quoting Rs. **1,00,899.00** against MRLF Rs. **77,070.00**

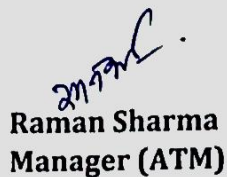
Considering the above said facts, LCAC recommends to award the contract to single bidder, technically qualified party who has quoted bid Rs. **1,00,899.00**, which is 30.91% higher than MRLF Rs. **77,070.00** and hence submitted for financial concurrence and approval for award of single tender by competent authority i.e. RED, SR.



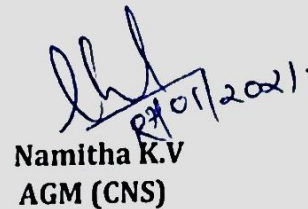
