- Consideration of recently issued technical instruction no. 56 dated 29.12.2021 has been accorded by the of competent authority vide note # 22 dated 11.01.2021 in the present case. Accordingly, exemption of EMD has been considered for the MSME/NSIC registered firms.
- Accordingly, subject proposal has been further scrutinized.

M/s Enkebee Infratech India Pvt. Ltd.

The detail of documents yet to be furnished by the bidder:

1. Power of Attorney was sought from the agency in the previous clarification; same has not been submitted by the agency. But, the bidders have submitted the document related to Companies act 2013 and of Memorandum and Article of association. Hence, we may seek power of attorney from the agency.
2. Agency is registered under the Companies ACT 2013. As per WNIT Para-B (VI) “Companies other than propriety firm shall , submit scanned copy of Authorization letter/ Power of Attorney along with copy of Certificate of Incorporation of the company under Companies Act showing CIN/LLPIN/Name of Director of the Company and Copy of Board Resolution regarding Authority to assign power of attorney. Proprietary firm shall submit scanned copy of Authority Letter/ Power of Attorney only if the tender is processed by a person other than proprietor”. These documents were sought in earlier clarification. Same has not been submitted by the agency. Bidders have submitted the document related to Companies act 2013 and of Memorandum and Article of association.
3. Letter of undertaking from depositor to bank was sought in previous clarification but same is not submitted by the agency.

The above said shortfall documents can be sought from the agency before award of work. Hence, it is recommended to open the financial bid of the above bidder.

M/s A. Constructions : The detail of documents yet to be furnished by the bidder:

1. As per WNIT, integrity pact has been uploaded by the agency. But, same is not duly filled.
2. Letter of undertaking from depositor to bank was sought in previous clarification. In this regard confirmation letter issued from the bank has been submitted by the agency. Hence, this point may be dropped.

The shortfall document at serial no. 01 can be sought from the agency before award of work. Hence, it is recommended to open the financial bid of the above bidder.

M/s RAJ Construction: The detail of documents yet to be furnished by the bidder:

1. EMD has not submitted by the agency. Vide letter no. Nil dated 10.11.2020 has requested for exemption from EMD as agency is registered under NSIC. In

accordance to the recently issued Technical Instruction no. 56, vide note # 22 dated 11.01.2021, competent authority has accorded the exemption of submission of EMD. Hence, bidder is applicable for exemption of EMD.

2. Submission of ESI was asked to the agency in previous clarification. But same has not been submitted by the agency.

The shortfall documents at serial no. 02 can be sought from the agency before award of work. Hence, it is recommended to open the financial bid of the above bidder.

M/s Anil Enterprises:

The documents submitted by the bidder are meeting with eNIT criteria. Hence, it is recommended to open the financial bid of the above bidder.

M/s Metal Engineering: The detail of documents yet to be furnished by the bidder:

1. The document indicating net worth has been attached by the agency. As per the document (refer ToC page no. 1010) the net worth value is Rs. 102,90,002.62 less than as required value of Rs. 123.16 lacs in published WNIT. Hence, this criteria does not meet with WNIT.
2. The Integrity pact submitted by the agency but not duly filled.

Hence, the document regarding net worth does not meet with the WNIT criteria. Hence, bid may be rejected.

M/s KNY Projects Pvt. Ltd. The detail of documents yet to be furnished by the bidder:

1. EMD has not submitted by the agency. In accordance to the recently issued Technical Instruction no. 56, vide note # 22 dated 11.01.2021, competent authority has accorded the exemption of submission of EMD. Hence, bidder is applicable for exemption of EMD.

The documents submitted by the bidder are meeting with eNIT criteria. Hence, it is recommended to open the financial bid of the above bidder.

M/s Generic Engineering Construction:

The documents submitted by the bidder are meeting with eNIT criteria. Hence, it is recommended to open the financial bid of the above bidder.

M/s Growever Infra Pvt. Ltd. :

Agency has not submitted the requisite documents except original bank guarantee. Hence, bid of the agency may be rejected.

After scrutinizing the documents of the above agencies, 06 nos. of agencies have been found eligible for opening of financial bid. The credential of 02 nos. of agencies (M/s

Metal Engineering and M/s Growever)has not been found is accordance with WNIT criteria.

Hence, it is recommended to open the financial bid of 06 nos. of agencies (except (M/s Metal Engineering and M/s Growever Infra Pvt. Ltd.).

As per Para 8.4 of DOP, the TS and DNIT of the subject proposal is accorded by GM (Engg.)-NR. Hence, GM (Engg.) NR-I is the competent authority for approval in this case.
