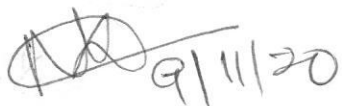

- The proposal is regarding provision of Crane/Total station/Gas Arc Welding Machine/Manpower services for short duration during DVOR installation work at Goa Airport, Goa at an estimated cost of Rs.6,39,500/ Excluding Gst.
- The fund for the proposed expenditure is identified from the AA&ES given by APD Goa station vide no. भा वि प्रा/गोवा/अभि(सि)डी वी ओ रा/19-20/20 दिनांक 05.07.2019 for Rs. 1,53,73,000/ towards construction of new DVOR in Navy land at Goa Airport, which comprises of CNS work of Rs. 14,33,636/ excluding Gst, labour cess and contingencies. (Total projected by CNS Rs. 17,42,441). (Placed in the file as Annexure "A")
- Since the proposed work is not included in the above AA&ES, and therefore re-appropriation of fund, for the proposed work amounting to Rs. 6,39,500/ excluding Gst. is proposed and recommended by CNS from the saving of above AA&ES i.e. in the above AA&ES for CNS work, there is a provision of one item at SH-1 online modular UPS (N+1) for Rs.7,77,270/ including Gst. (Rs.6,58,703 plus Gst. Rs.1,18,567) has been procured by RCDU Delhi and dispatched to the station, as stated by the CNS department (NP-03/N-7) and proposed from saving out of this fund.
