However, first annual escalation will be effected after One year + Six months w.e.f. commencement of the License and subsequent escalation on completion of One year therefrom. Any addition to the number of trolleys, will be charged on pro rata basis of the License fee.

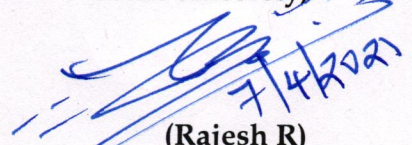
3	License period	Three (03) years (considering Business Incubation Period of 30 days from date of issue of award letter and gestation period of 90 days from the 31 st day of after issued of award letter) or from the date of taking over, whichever is earlier.
4	Security Deposit (non-interest bearing)	Four Months License Fee : Rs. 3,32,000/- Deposit towards Utility/Electricity: Rs. 50,000/- ----- Total SD required : <u>Rs.3,82,000/-</u> Security Deposit may be deposited in the form of Bank Guarantee from a Nationalized/Scheduled Bank in favour of Airports Authority of India payable at Calicut/Kondotty, which will be refunded (without interest) after vacation of the space & settlement of all dues. The Bank Guarantee is to be obtained for an entire period of the contract plus Six (06) months overlapping period. Bank Guarantee from Co-operative bank will not be accepted. No interest is payable on Security Deposit.

5. The Earnest Money Deposit shall be forfeited and the bidder shall be debarred from further participation in AAI tender(s) for a period of One (01) year, on account of non-completion of the following terms.

- a) Intimating by submitting a signed copy of this award letter as acceptance of the terms and conditions of award letter within 07 days from the date of issue of this award letter.
 - b) Payment of One (01) month advance License fee of Rs.97,864/- (License Fee & GST @ 18%) within 30 days from the date of award letter.
 - c) Payment of Security Deposit within 30 days from the date of award letter.
 - d) Execution of agreement on formal Stamp Paper worth Rs.200/- within 30 days from the date of award letter.
6. If at any stage, AAI finds that the party had submitted any false/wrong/concealment of information/document affecting eligibility criteria of the facility in such case, Security Deposit/Bank Guarantee shall be forfeited and party is liable to be debarred for three years for participation in AAI tenders.

7. If the licensee does not operate the license up to 50% of the license period, then the Licensee may be debarred from participating any tender in AAI for a minimum period of (01) One Year, in addition to levy of demurrage charges as per the terms and conditions specified in the NIT.
8. The Licensee shall use the space for the purpose for which the license is granted, and shall not use for any other purpose, whatsoever.
9. If, any trolley is found to be missing the cost of the same shall be recovered from the Licensee. Therefore, it is advised to deploy sufficient manpower to keep track of PBT's.
10. The Licensee shall strictly comply with the Special Terms and Conditions for the License mentioned in NIT.
11. The Licensee after completion of contractual formalities viz. acceptance of award, submission of Security Deposit, Execution of License Agreement may co-ordinate with AAI Technical Department for proper handing over/ taking over of Passenger Baggage Trolleys.
12. This award letter & NIT will form part and parcel of Agreement.
13. A Stamp paper worth Rs.200/- is to be submitted to this Office for executing the Agreement.
14. Your acceptance to the above terms and conditions must be forwarded to this office within Seven (07) days of receipt of this award letter. It is therefore, requested to return a sealed and signed copy of this award letter as a token of your acceptance of the above terms and conditions
