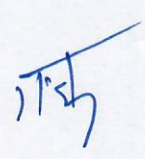

### 2.0 RESPONSE TO "NIT"

The tender was re- invited for 3 schedules viz A, D & E for the subject work as the initial tender has only single bid in these 3 schedules of work. The bids have been opened and the schedule wise summary is as below



**a) Sch-A – Shatrunjay Dam**

- (i) M/s Nektor Engineers & Project Consultants Pvt Ltd., Ahmedabad-15
- (ii) M/s Pan India Consultants pvt Ltd & M/s Raj Technologies Gurugram.
- (iii) M/s MST-DSR JV Noida

**b) Sch-D – Guwahati River Front**

- (iv) M/s Nektor Engineers & Project Consultants Pvt Ltd., Ahmedabad-15
- (v) M/s Pan India Consultants pvt Ltd & M/s Raj Technologies Gurugram.
- (vi) M/s MST-DSR JV Noida

**c) Sch-E – Umrangso Reservoir**

- (vii) M/s Nektor Engineers & Project Consultants Pvt Ltd., Ahmedabad-15

**3.0 BID EVALUATION**

M/s MST- DSR JV Noida & M/s Nektor Engineers & Project Consultants Pvt Ltd has submitted common CV for CAT –‘A’ Surveyor viz Cdr (IN) P. Jayapal (Retd) and hence no marks can be given to both the bidders for CAT –‘A’ Surveyor.

M/s Pan India Consultants Pvt Ltd has submitted the resume of Shri. Nishant Bansal but has not specified that if his CV has been opted for Marine Engineer and hence its score has not been considered in marking. Further, M/s Pan India Consultants Pvt Ltd needs to clarify the ToR for M/s SPARC work order and the quantum of work vide RSAC UP work order.

The clarifications were accordingly raised with all the bidders and due replies have been received from all the firms and compiled (Annex-1A, Annex-1B, and Annex-1C).

*M/s Nektor has replaced the bio data of Commodore P Jayapal with Cdr (Retd) with Cdr (Retd) K L Rao and has not been considered for marking purpose.*

*M/s MST- DSR JV Noida has submitted written undertaking from Commodore P Jayapal and have opted for Sch-A in absence of insufficient solvency for all three schedules of work.*

*M/s Pan India Consultants has submitted the ToR for M/s SPARC Work order and have forwarded the quantum of work for M/s RSAC U.P which satisfies the pre-qualification criteria as laid in the tender document.*



The bids for Sch-A, Sch- D & Sch-E has been evaluated as per the laid criteria in tender document. The details of pre qualifications and scoring is attached as Annex-2A, Annex-2B, Annex-3A, and Annex-3B & Annex-4A Annex-4B. The company/firm obtaining 75 marks are eligible for opening of financial bids.

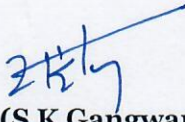
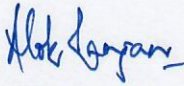
#### **4.0 TEC MEETING & RECOMMENDATIONS**

The committee report was scrutinised and a meeting of the designated TEC was again held on 03.03.2020 and following observations vis a vis clarifications received has been made

- i. M/s MST- DSR JV Noida & M/s Nektor Engineers & Project Consultants Pvt Ltd has submitted common CV for CAT -'A' Surveyor viz Commodore (IN) P. Jayapal (Retd). Accordingly, clarification were sought from both the bidders to obtain an undertaking from Commodore P Jayapal and it was mentioned that in case the undertaking is received from both the bidders the marks will not be allotted to both the bidders . However, in clarifications M/s MST DSR has obtained undertaking from Commodore (IN) P. Jayapal (Retd) that he will work with M/s MST-DSR JV Noida and M/s Nektor Engineers and Consultant's has submitted a fresh CV of Cdr P Lakshmana Rao.
- ii. In the interim a second opinion from M/s PwC it has been brought out that the marks should not be given to both the bidders due to conflict of interest as per T&C of the tender. The bidder in case successful may be requested to replace the CV after award of work and therefore no marks to be allotted to both the firms.
- iii. M/s Pan India Consultants Pvt Ltd- The quantum of hydrographic survey work vis a vis the RSAC work order has been self-certified by the firm and not by the client i.e. RSAC UP.



Accordingly, TEC has decided to technically disqualify all three bidders as all the bidders are not able to meet/obtain minimum marks i.e 75. Accordingly, TEC recommends retendering for all the 3 schedules of work.
