3.1 Technical Evaluation

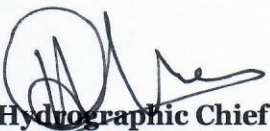

4.0 "TEC" RECOMMENDATIONS

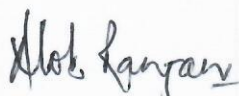
The above submissions were discussed in depth by TEC. The TEC observes that as regards to fulfilment of pre qualification all the bidders are qualified.

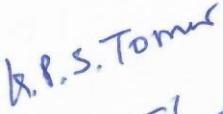
Accordingly, the TEC recommends to consider opening of Financial bids as all of the bidders are qualified. Their scores are as enumerated below
