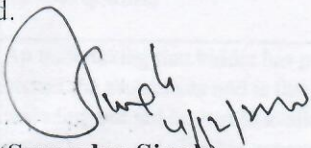

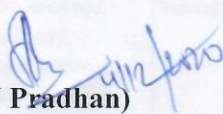
(4) Observation of TEC:

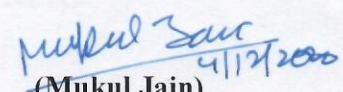

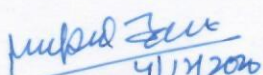

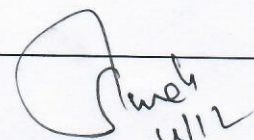
