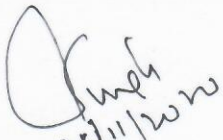

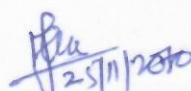

Ltd., New Jamdeeh Pandey Colony District Hospital, Kailly Road Basti, has not submitted Letter of Signing Authority, Profit & Loss Account, similar work completion/experience certificate, Turnover for last 3 years and Tender document and current solvency certificate (within 1 year) and other documents of the firm. Therefore, the firm may not be considered technically qualified.
