1. Tender for providing vehicles on monthly hire basis to NHAI, PIU-Jabalpur with tender ID_2020_NHAI_39290_1 on 01.01.2020.

2. Committee of following members was constituted for opening the said tender.

3. The bid opening date was changed from 14.01.2020 to 16.01.2020 & corrigendum for the same was published on 14.01.2020. Accordingly the committee met at PIU-Jabalpur on 16.01.2020 at 03 : 00 PM & started the proceedings of bid opening.

4. At 03 : 00 PM none of the bidders send their representatives for witnessing the bid opening but later on Sh. Deepak Upadhyay representative of Mahima Travels & Sh. Gellete John representative of M/s Krishna Travels joined the Bid opening process.

5. The Online Technical bid was opened at 15:23 PM on 16.01.2020 in presence of all the committee members (Attendance Sheet Enclosed) and following is observed:

(a) Total 2 nos. of bidders participated in the said bid namely :

- (b) The required documents as per RFP have been submitted by both the bidders in online as well as physical form.
- (c) DD of Rs. 1000/- for Tender cost have been submitted by both the bidders which are as per RFP.
- (d) Single DD of Rs. 25,000/- for EMD has been submitted by both the bidders which are as per RFP. It is elaborated here that the submitted single DD by the Bidders for all three vehicle category together. Hence the submitted Bid will be considered 1 bid for each bidder.
- (e) Vide terms & Conditions S.NO.1 the vehicle supposed to be provided shall be in good condition (vehicle manufacture before the year 2019 and /or have run more than 10,000 Km. will not be considered) and physically fit for smooth transportation. Following is found as per the Bidders submission :

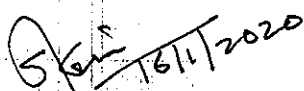

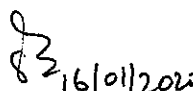
6. Committee is in their opinion that:

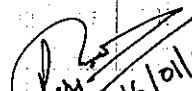
- (a) Since Bidder no. 1 (M/s Mahima Travels) has submitted that vehicle Innova Crysta is 2018 Manufacturing hence as per the terms and Conditions at S.No. 1 tender condition not fulfilled by the bidder. Hence the bid is recommended to be declared as non-responsive.
- (b) As bidder no.1 (M/s Mahima Travels) is disqualified as explained at Para-6 (a) the bidder no. 2 (M/s Krishna Travels) becomes the sole technically qualified bidder.

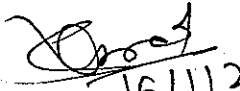
7. Vide Para 6, the Committee observed that in circumstances of single qualified bidder, the tender should be recalled. Hence Committee not recommended for opening of financial bid.
