- **Member No. 3** - **Shri Paras Bansal, DM(T).**

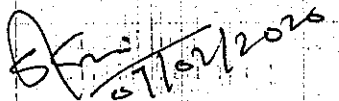

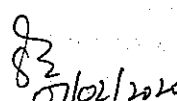
3. Brief summary of bid evaluated cost of both the bidders is as follows :-

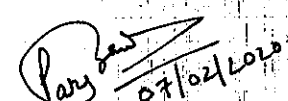

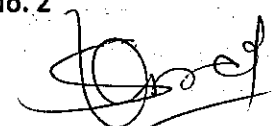
4. The bid evaluated cost is calculated as per Bid evaluation procedure defined at Para 23 of terms and condition of RFP. As per Para 9 of Terms and Condition of RFP, the work was to be awarded to the bidder whose bid evaluated cost is L1 (lowest quoted rate) in a particular category of vehicle. In the present scenario, Mahima Travels is L1 in the category of Innova Crysta or Equivalent and Krishna Travels is L1 in the category of Tata Indigo or equivalent.

In view of above, the committee recommends that work of "Providing running and maintenance of Commercial vehicles 02 in nos. in the category of Indigo or equivalent" to be allotted to successful bidder (L1) M/s Krishna Travels, Jabalpur and the work of "Providing running and maintenance of Commercial vehicles 01 in nos. in the category of Innova Crysta or equivalent" to be allotted to successful bidder (L1) M/s Mahima Travels.

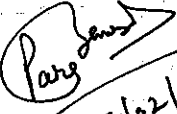
