Competent Authority, NHAI approved the estimate for the subject work for Rs. 12.87 cr. vide letter no. NHAI/Tech/Maintenance Estimate/NH-2/30/146106 dt.20.12.2019. The estimated project cost is Rs. 12.87 cr. with 06 (six) months time period for Providing and fixing square pipe fencing (1.95m height) in the portion from Km.134.000 to Km.151.750 in Mathura Town and Km.184.000 to Km.199.650 in Agra Town in Section of NH-2.

Notice inviting tender for the subject work was issued on 17.03.2020 with the bid due date 18.05.2020. Bids were to be submitted only at <http://etenders.gov.in> on or before 18.05.2020. Bids received online were to be opened on 19.05.2020.

Documents listed at Clause 12 of ITB of bid document i.e. EMD/Bid Security, Tender Fee, Written Power of Attorney and Affidavit duly notarized, Original experience certificate, undertakings etc. were to be uploaded in scanned copies during submission of e-bid by the bidder on or before 18.05.2020

The online bids submitted by the bidders were opened on 19.05.2020 by committee constituted for opening and evaluation of bid comprising of the following members:-

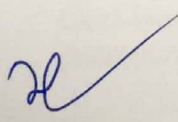
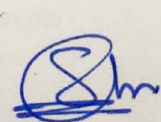
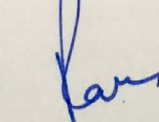

The above committee recommended to evaluate the technical proposals of all the eleven (11) agencies as per provisions of bid documents through Financial Consultant.

M/s Darashaw & Company Pvt. Ltd. has been appointed as Financial Consultant vide note no. NHAI/CMU/MTR/PGR-Mathura & Agra/2019/D-56450 dt.04.12.2019 and this unit LOA no. 56879 dt.03.01.2020 by National Highways Authority of India, CMU-Mathura for the evaluation of proposals received for the project. The Financial Consultant submitted their report of technical evaluation (Annexure-I).

On evaluation, it was observed that some of the data/information provided by the bidders is not completely adhering to clauses given in bid document. Therefore, the evaluation process, clarifications were asked from all the bidders under clause 23.4 of ITB of bid document.

On receipt of clarifications from all bidders, the bids were finally evaluated by Financial Consultant, M/s Darashaw & Company Pvt. Ltd. and submitted its recommendations dt.06.06.2020 (copy enclosed).

The bids of all the eleven (11) bidders were evaluated by the Financial Consultant and were reviewed by the committee and following are the findings:-

The reason for disqualification of M/s G.S. Express Pvt. Ltd. is as under:-

"The Bidder has not submitted any replies within the deadline provided for the submission of its replies. However, the fact that non submission of replies despite giving the proper opportunity and final warning for rejection of bid subsequent to non-submission of replies, shows a lack of interest on part of the Applicant. So, in view of this, the applicant may not be considered for next stages of bidding.

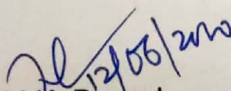
However, the Authority may decide whether to consider the bid for further stages of bidding, subject to necessary compliance as suggested in the replies to clarification".

The Committee is of the view that since M/s G.S. Express Pvt. Ltd. has not submitted the POA and has also not responded to queries of PIU despite giving the proper opportunity and final warning for rejection of bid, the bidder may be disqualified.

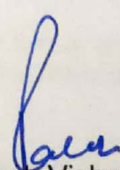
