- ii) M/s Laxmi Roadways

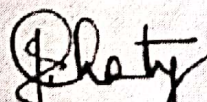

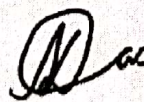
4. It was found that as per clause 12.2 of ITB, the following documents had submitted by the bidders:-

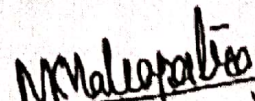

- (iii) Affidavit duly notarized has been submitted by 3 both Bidders.

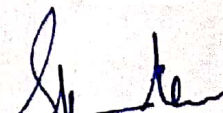
