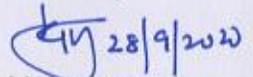
2. You are requested to return a duplicate of the LOA as an acknowledgement and sign the Contract Agreement within the period prescribed in Clause 1.3 of the RFP.

In case of failure of submission of Performance Security within the additional 60 (Sixty) days time period, the award shall be deemed to be cancelled and bidder will be suspended for participation in the tendering process for the work of MoRTH/NHAI/NHIDCL and work under other Centrally Sponsored Schemes for a period of One Year from the bid due date of this work.
