Minutes of Meeting of Technical Evaluation Committee on 03.07.2020 for Repair and Maintenance of Mirzachauki-Farakka section of NH-80 (3 packages) in the State of Jharkhand- reg.

The Committee for the cited subject has been constituted vide this office letter no. NHAI/RO/RNC/JH-RRM-Admn/332 dated 02.07.2020 with the following members:

2. The bids were opened electronically on the scheduled date and time on 07-07-2020 in the presence of Committee members. The summary of evaluation package wise is as follows:

Package-I (km 191 to km 196)

3. Two bids were received as follows:

- i. M/s Anand Consultants
- ii. M/s Baba Projects Pvt Ltd

The bids were evaluated based on the criteria set forth in the RFP. Detailed evaluation is placed at **Annexure-I** enclosed.

4. It was observed that the bank guarantee for bid security submitted by M/s Anand Consultants is not according to the format enclosed with the RFP even though it is of adequate value and validity. The Committee members discussed the issue and opined that as per Ministry guidelines for evaluation of bids (circular no. RW/NH-37010/4/2010/PIC-EAP(Printing) dated 16-01-2017, the variations/ clarifications which do not change the basic character of the offer may be sought from the bidders and acceptable under some conditions. Condition (c) reads: "Minor deficiency in Power of Attorney and Bank Guarantee".

5. The Committee decided that the bidder may be requested to immediately change his bank guarantee as per the RFP format. Meanwhile, in view of urgency of work to ensure safety and motorable condition of highways, financial bid of both the bidders may be opened.

Package-II (km 197 to km 215)

5. Two bids were received as follows:

- i. M/s Anand Consultants
- ii. M/s Baba Projects Pvt Ltd

The bids were evaluated based on the criteria set forth in the RFP. Detailed evaluation is placed at **Annexure-II** enclosed.

6. It was observed that the bank guarantee for bid security submitted by M/s Anand Consultants is not according to the format enclosed with the RFP even though it is of adequate value and validity. The Committee members discussed the issue and opined that, as per Ministry guidelines for evaluation of bids (circular no. RW/NH-37010/4/2010/PIC-

Package-III (km 260 to km 282.900)

8. Only one bid of M/s Anand Consultants was submitted for this work. The Committee observed that this is a case of single bid and recommended for fresh call of bids for this package.
