Minutes of the Bid Evaluation Committee on Technical proposals

As per NIT No.7 dated 26.06.2020, the tender was invited as 3rd call for the subject work and in which the schedule date of submission was on 26.07.2020. Accordingly, the same has been opened by the Bid Evaluation Committee on 29.07.2020 and for which Only Single Bid of **M/s. ARMENGE Engineering and Management Consultants Pvt. Ltd.** was uploaded.

2. As per Policy Circular cited 3rd above and in which vide sl. no.7.3, it is mentioned as below:

- i. In case only a single bid is received normally tender process may be cancelled and rebidding done by giving 4 weeks notice.
- ii. If re-bidding also results in receipt of single bid then it should be opened and the bid amount should be compared with the estimated cost. In case of the bid amount being within 15% of the estimated cost, then acceptance of the bid may be considered with proper justification and reasons.
- iii. If the justification given for the acceptance of bid is found reasonable then the consultancy proposal should be accepted by the next higher authority i.e. by the Chairman.

3. As the single bid was received on 3rd call and as such as per NHAI Policy Circular mentioned above vide sl. no.7.3 (i), the bid is to be re-invited and accordingly the tender was invited as 4th call vide above said notification cited 1st above with due date of submission of Technical bid was on **20.10.2020**.

4. Accordingly, the Constituted Bid Evaluation Committee has opened the Technical bid on the scheduled date of **21.10.2020** and in which it is noticed that the following Safety Consultant has submitted the Technical bid.

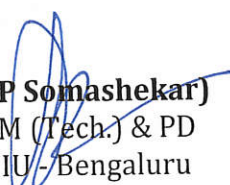
