RO accorded approval to the bidding documents vide mail dt.04.01.2021 at 16:12 Hrs

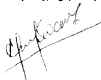
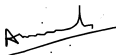

Recommendation of the Committee

6. The Committee has evaluated the technical bid(s) as per the RFP. Detailed evaluation sheet of the technical bid(s) is **attached herewith.**
7. The Committee recommends to relax following clauses:
 - (i) Clause no.4.4 A (i) of the RFP regarding availability (either owned or leased or rented) of items of construction equipment and vehicles. The document(s) regarding key equipment should contain information in respect of name of the key equipment, its capacity, age, VRN,



owned/ leased/ rented, etc. The bidders have submitted documents regarding the availability of key equipment; however, many bidders' submissions miss one information or other, or does not meet age criteria in 1-2 key equipment. The bidders have executed works of higher acumen/ finances; therefore, the condition may be relaxed for now and may be ensured during the execution of the contract.

An Undertaking Mentioned in Section- III Appendix 1.7 [ref. clause 4.4 B (b) (i)] regarding deployment of key equipments have been obtained from all the bidders.

- (ii) Clause no. 4.4 B (ii) of the RFP regarding availability of personnel for this work with Qualification & Experience as stated in the Appendix to ITB. The bidders have claimed Qualification & experience of Key Personnel as desired in RFP, however, proper documents for qualification/ experience have not been submitted by many bidders. The bidders have given undertaking that the information in the bio-data is correct. The condition may be relaxed for now and may be ensured during the execution of the contract.

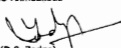
