

1. M/s KP Instruments, Nagpur

The bidder is Registered with MSME vide no. UDYAM-MH-20-0004827 and have also submitted FDR No. 16220310261064/455304 dated 13.11.2020 issued by UCO Bank for Rs. 3,44,068/-.

- I.** Bidder is registered with GST Authorities under GST Certificate (GST No. 27AAGFK8605DIZF) and registered with registrar of firms, Nagpur under registration no. NGP-9276/2005-06. **The EQR clause 3 (i) is fulfilled by the bidder.**

- IV.** Firm have not submitted turnover statement. **The EQR clause 3 (iv) is not fulfilled by the bidder.**
- V.** Bidder has submitted undertaking dated 11.11.2020 for not corrupt/fraudulent practices. **The EQR clause 3 (v) is fulfilled by the bidder.**
- VI.** Since firm have not submitted turnover statement for last 05 years so it could not be ascertain have firm not suffered any loss in more than 02 years during available last 05 consecutive balance sheets or not. **The EQR clause 3 (vi) is not fulfilled by the bidder.**
