After opening of envelope-1, the following bidder meet the NIT criteria and found eligible for opening of financial bid.

(i). M/s R K Mishra And Company

Following bidders are not meet the NIT criteria due to non-submission of required documents as per NIT Criteria. Therefore, shortfall documents were asked through CPP portal and the following are the observations as per received shortfall documents of bidders:

- (i) M/s Bajrang Nirman Pvt. Ltd.
- (ii) M/s S. Singh & Company
- (iii) M/s JCC Infratech Pvt. Ltd.
- (iv) M/s Sai Builders

The shortfall documents have been scrutinized as per Annexure-I (copy attached) as per details given below: -

(i) M/s Bajrang Nirman Pvt. Ltd:

1. Documentary proof of owning/ leasing is submitted.
2. Authorization letter/ Power of Attorney is submitted.
3. Work experience along with copy of BOQ has not submitted as per NIT Criteria.

Recommendation: Hence, agency is not meet the NIT criteria. Agency application may be rejected.

(ii) M/s S. Singh & Company:

1. Documentary proof of owning/ leasing and processing (copy of purchase invoice)

- for Hot Mix Plant Batching & Mixing plants and sensor pavers not submitted.
2. Completion Certificate not submitted as per NIT criteria.

Recommendation: Hence, agency is not meet the NIT criteria. Agency application may be rejected.

(iii) M/s JCC Infratech Pvt. Ltd.:

1. Completion Certificate not submitted as per NIT criteria.
2. EPF & ESI Registration Certificate not submitted.

Recommendation: Hence, agency is not meet the NIT criteria. Agency application may be rejected.

(iv) M/s Sai Builders:

1. Copy of Tender Fee paid document submitted.
2. EMD Declaration submitted.
3. Unconditional Acceptance submitted.
4. Documentary proof of submitted T&P not readable.
5. ESIC Registration/Undertaking for submission of ESIC in case of L-1 not submitted.
6. PQ Performa not submitted.
7. Authorization submitted.
8. Completion certification not submitted as per NIT criteria.

Recommendation: Hence, agency is not meet the NIT criteria. Agency application may be rejected.

In view of above 05 applications were received and after scrutiny of shortfall documents, only 01 agency meets the NIT Criteria for opening of Financial Bid.

As per DOP Para **2.38 (b)** "Open Tender: - If against open/limited tender there are minimum three responses from different three tenderers, though resulting in single valid bid, it will be treated as Open Tender".
