- 3) You are requested to deposit an amount of **Rs. 92,580/-** (Rupees Ninty two thousand five hundred and eighty only) towards Security Deposit within 15 days from the date of issue of this letter, failing which, the same will be deducted from your running bills as per Clause – 1A, page – 15 & 16, of the tender document.
- 4) You are requested to comply with the provision of contract Labour (Regulation and abolition) Act of 1970 and contract Labour (Regulation and abolition) Central Rules 1971 and Minimum Wages Act & Rules there of Central and State Governments.
