4. You are requested to comply with the provision of Contract Labour (regulation and Abolition) Act of 1970 and Contract Labour (regulation and Abolition) Central Rules 1971 and minimum wages act and rules thereof of Central and State Governments.
5. You are requested to get yourself registered with GST tax collection authorities, if applicable and submit the documentary evidence to Engineer- In-charge within 30 days of issue of award letter.
6. You are also directed to contact Sr. Manager (Engg-Civil), AAI, Shillong Airport, Umroi immediately who will arrange to hand over the site to you.

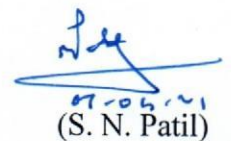

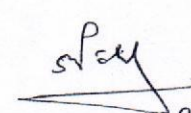

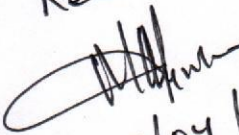
