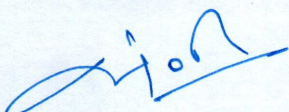

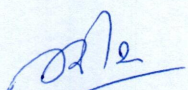

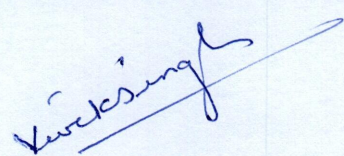

- ii. Agency has not submitted registration certificate.

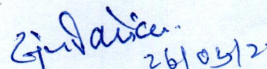
In view of above, agencies shall requested to comply with the submission of documents as per NIT eligibility criteria.
