However, firm now submitted same authorization letter, which was submitted earlier in Envelope-1. Hence, authorization letter as submitted by the agency is not acceptable due to non-submission of a copy of Board Resolution regarding Authority to assign Power of Attorney as per NIT para B (v).

required. Hence, work experience of Adani electricity and MSC bank is not acceptable due to non-submission of work experience similar to SITC of split AC's, window, cassette type AC's as per NIT para C(i) and Non-submission of TDS certificate & C.A. certificate as per NIT para C(i) being work experience from private firm,

- 3.2 **Copy of Power of Attorney/Authorization Letter along with Board Resolution regarding Authority to assign Power of Attorney** – Agency has not submitted copy of Power of Attorney/Authorization Letter along with Board Resolution regarding Authority to assign Power of Attorney in short fall folder within the stipulated date & time. Instead of the same, agency now submitted a letter stating that Power of Attorney/Authorization Letter is not applicable as tender has been signed & processed by one of the board directors of the firm. The statement of the firm regarding non submission of required document is not acceptable, as a copy of Board resolution regarding Authority to assign Power of Attorney is required as per NIT para B (v).

3.3 **Comments:**

It may be seen from the above that, the firm does not qualify due to following non compliances of tender document.

- 1) Not meeting Work experience criteria as per NIT terms & conditions of Envelope-1 vide para C (i)
- 2) Non submission of a copy of Board resolution regarding Authority to assign Power of Attorney is required as per NIT para B (v).

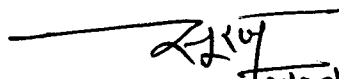

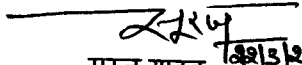
