Sir,

Based on the recommendations of the [LCAC dated 23.02.2021](#) and [approval of the Competent Authority](#), the tender for the facility of F&B outlet at Bus Lounge in SHA of Trichy International measuring 10 sqm was invited on 24.02.2021, with the approved MRLF of Rs. 73,410/- per month plus applicable GST and other charges inclusive of space rent measuring a total of 10 sqm at SHA, for a period of 9 months through NIC CPP Portal vide [E-Bid No : 2021_AAI_71284_1](#) dated 24.02.2021, with the last date of submission of tender on 03.03.2021. On perusal of the NIC CPP Portal on 03.03.2021, the tender was extended till 10.03.2021(first extension).

2.	M/s R K Enterprises, Jaipur (Shortfall documents attached in ToC)	Submitted all the requisite documents as per the NIT conditions.

In view of the above, we may technically qualify both M/s Navilan Enterprises and M/s R K Enterprises for further processing of the tender.
