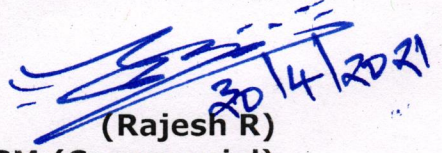

2	License Fee	Quoted MMG of Rs.3,54,000/- per month OR Revenue Share of Rs.30/- per trip/booking multiplied by total number of trips in the particular month, whichever is higher plus applicable GST, Utility Charges viz. Electricity/Water, and applicable Space rent & CAM Charges. The License Fee will be subject to annual escalation as per the relevant clauses of NIT document.

4	Security Deposit (non-interest bearing)	Required Security deposit: Rs.14,16,000/- Electricity Security deposit: Rs.2,57,000/- ----- Total Security Deposit : <u>Rs.16,73,000/-</u> Security Deposit may be deposited in the form of Bank Guarantee from a Nationalized/Scheduled Bank in favour of Airports Authority of India, which will be refunded (without interest) after vacation of the space & settlement of all dues. The Bank Guarantee is to be obtained for an entire period of the contract plus Six (06) months overlapping period. Bank Guarantee from Co-operative bank will not be accepted. 5. The Earnest Money Deposit shall be forfeited and the bidder shall be debarred from further participation in AAI tender(s) for a period of One (01) year, on account of non-completion of the following terms.
- Intimating acceptance of terms and conditions of award letter within 07 days from the date of award letter.
 - Business Incubation Period of 15 days from the date of issue of award letter for completion of all post award formalities and commencement of License as per the timelines indicated in NIT.
 - Payment of One-month advance License Fee amounting to Rs.4,17,720/- (Including GST @ 18%) within Business Incubation Period i.e. within 15 days from the date of award letter.
