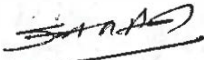

1. This has reference-Letter of Intent no. भाविप्रा/निमु/अभि (सि.)/अयोध्या /पेवमेंट वर्क/1417, दिनांक: 26.08.2021 your tender for the work mentioned above was accepted on behalf of Chairman, Airports Authority of India at the item rates quoted by you totaling to Rs. 98,55,00,000.00 (Rupees Ninety Eight Crore Fifty Five Lakh only) (excluding GST) which is 11.80% below the estimated cost put to tender of Rs. 111.73 Cr. (Rupees One Hundred Eleven Crore Seventy Three Lakhs Only) (excluding GST).
2. You are requested to attend the office of the Jt G. M. Engg (C), AAI, Rajiv Gandhi Bhawan, Safdarjung Airport, New Delhi by 13.12.2021 to sign and complete the Contract Agreement. The contract agreement shall be executed on a non-judicial stamp paper of value of Rs. 100/- (Rupees One Hundred Only) and the cost of the stamp paper shall be borne by you. Jt G. M. Engg (Project), AAI, Ayodhya Airport shall be the Engineer-in-charge of the work.

3. You have been exempted for deposition of EMD for the subject tender. Therefore, you are requested to deposit Rs. 4,92,75,000/- (Rupees Four Crore Ninety Two Lakh Seventy Five Thousand Only) towards Security Deposit within 10 days from the date of issue of this letter failing which, the same will be deducted as per condition Clause -1(A) on page no. GCC- 17 of the tender document.
4. Within 30 days of issue of this work order, you shall submit to AAI, a performance Guarantee as per clause 1 on GCC 16 of Tender Document and schedule E of GCC 131 for an amount of Rs. 2,95,65,000/- (Rupees Two Crores, Ninety Five Lakhs, Sixty Five Thousand Only) in the form of a Bank Guarantee from a Nationalized/Scheduled Indian bank but not from any Co-operative or Gramin Bank in the proforma appended in the tender document.
5. You are requested to comply with the provision of contract labour (Regulation & abolition) Act of 1970 and contract labour (Regulation & Abolition) Central Rules 1971 and minimum wages Act and Rules there of Central and State Govts.
6. You are also directed to contact Jt G. M. Engg (Project), AAI, Ayodhya Airport immediately who will arrange to hand over the site to you.
7. Please note that the time allowed for carrying out the work shall be 12 months (Planning and Execution) [including 02 months considered for rain of 01 monsoon season] and same shall be reckoned from the date of issue of this letter.
8. Any further correspondence in connection with the contract should normally be addressed to the Engineer In-Charge.
9. Please acknowledge the receipt and return the duplicate copy of this letter enclosed herewith after duly signing it to the undersigned as a token of acceptance.
