TENDER FEE AMOUNT :- Rs. 1,180/- Payable through NEFT/ RTGS.

EMD :- Declaration of Earnest Money Deposit (EMD) on Contractor's letter head will be required on CPP Portal only.

EXPERIENCE:- Three works, each of Rs.13,94,168/- or two works, each of Rs. 17,42,710/- or One work of Rs. 27,88,337/- in single contract of similar nature of work i.e. Supply & Installation of factory made office furnitures e.g. tables, chairs, etc. in offices of prominent institution e.g. airports, banks, corporate offices etc. during last seven years ending on last date of submission of bid in India. The experience certificate of works completed pre GST era. Competition amount will be divided by 1.18 (to exclude pre GST Tax of VAT 18%) to make it at par with experience certificate of post GST era but excluding GST.
