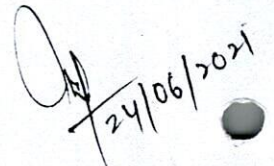

Please deposit Rs.1,23,120/- (Rupees one Lakh twenty three Thousand one hundred twenty only) towards security deposit within 10 days from the date of issue of this letter failing which, the same will be deducted from your running bill as per condition of clause no. 1A at page no.-16 of Contract document.
3. You are requested to comply with the provision of contract labor (Regulation and abolition) Act of 1970 and contract labor (Regulation and Abolition) central rules 1971 child labour (Prohibition & Regulation) Act 1986, construction workers (Regulation of Employment and Condition of Service) Act 1996, Building and other Construction workers welfare cess Act 1996 as specified in Clause -37 on page no. 66 of GCC of Tender and rules of Central and state Government and minimum wages Act and rules thereof of Central and State Government.
4. You are requested to get yourself Registered with Service tax collection authorities, if applicable and submit the documentary evidence to Engineer-in-Charge within 30 days of issue of award letter.
