2. **Coordination In-Charge (CIC)** at Guwahati Airport shall be the Officer-In-Charge of the work. You are requested to attend the office of **Executive Director-II (JVC/PPP)**, CHQ, Rajiv Gandhi Bhawan, New Delhi by 22.10.2021 to sign and complete the contract agreement. The contract agreement shall be executed on a non-judicial stamp paper of value **Rs.100/-** (Rupees One Hundred only) and the cost of the stamp paper shall be borne by you.
3. Please deposit **Rs. 58,70,242/-** (Rupees Fifty Eight Lakhs Seventy Thousand Two Hundred & Forty Two Only) towards **Security Deposit** as per Clause 2 of GCC of tender document, within 10 days from the date of issue of this letter, failing which, the same will be deducted from your running bills as per terms & conditions of contract document.
4. Within **30 days** of issue of award letter, you shall submit to AAI, a **Performance Guarantee** as per condition of Clause 3 of GCC of tender documents, for an amount of **Rs.35,22,145.00** (Rupees Thirty Five Lakhs Twenty Two Thousand One Hundred Forty Five Only) in the form of Bank Guarantee on the Proforma appended at Annexure-5 of tender document.

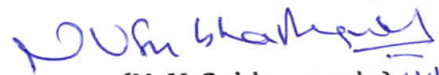

6. You are also directed to contact **Coordination In-Charge (CIC)/Senior most CNS/ATM In-charge**, Guwahati Airport immediately, who will be the nodal officer for this work. The Joint Venture Monitoring Unit (JVMU) at the airport is functioning under CIC.
7. Please note that the time allowed for carrying out the work shall be **36 Months** and same shall be reckoned from the **10th day** after issue of this letter.
8. Any further correspondence in connection with the contract should normally be addressed to the **Deputy General Manager (Engg-C)- JVC/PPP**, Airports Authority of India, Room No. 256, C-Block, Rajiv Gandhi Bhawan, Safdarjung Airport, New Delhi-110003.
9. The payment shall be governed as per the payment terms mentioned in clause 14 & 16 of General Conditions of Contract of the tender document.
10. In terms of Clause (24.3.1) of Concession Agreement; and Clause- 5 of Notice Inviting e-Tender, the Concessionaire **Adani Guwahati International Airport Limited (AGIAL)** shall bear the cost associated with the appointment of Independent Engineer.

The Independent Engineer shall submit the bills on quarterly basis (duly certified by authorized signatory of Independent Engineer and endorsed by Chief Airport Officer of AGIAL) to JVMU at Airport. Thereafter, bill will be verified and payment released by JVMU at the Airport.
