2. **RBA Hospitality and Hotels Pvt Ltd, Ahmedabad** has submitted the revised Annexure - G in proper format and **qualified technically.** It is resulted as single tender after technical scrutiny, the committee has recommended for forwarding to Commercial - SR/RHQ for further scrutiny and approval for opening of Financial Bid of single tender from the competent authority.
