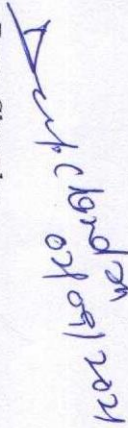

Whereas, requested shortfall documents have not been submitted by **M/s SPECIALIST HOUSEKEEPING & SAFETY INDIA PRIVATE LIMITED**. After evaluation, five (1-M/s VANITY HOSPITALITY SERVICES, 2-M/s ESCORT SERVICES, 3-M/s DEV ASSOCIATES, 4-M/s MEENAKSHI OVERSEAS and 5-M/s Gopal Lal Meena) parties are qualified in technical evaluation process.
