Your item rate e-tender for the work mentioned above is hereby accepted on behalf of Chairman, Airports Authority of India, amounting to Rs. 19,02,92,240.00 (Rupees Nineteen Crore Two Lakh Ninety Two Thousand Two Hundred Forty only) Excluding GST, which is 18.63% (Eighteen point Six Three percent) below the estimated cost put to tender of Rs. 23,38,80,000.00 (Rupees Twenty Three Crore Thirty Eight Lakh Eighty Thousand Only).
2. Jt. G.M. (Engg-C) / D.G.M. (Engg-C), Udaipur Airport shall be the Engineer-in-Charge of the work. You are requested to attend the office of Jt. G.M. (Engg-C), Airports Authority of India, Rajiv Gandhi Bhawan, Safdarjung Airport, New Delhi-110003 within 10 days from the date of issue of this letter to sign and complete the contract agreement. The contract agreement shall be executed on a non-judicial stamp paper of value Rs. 100/- (Rupees One Hundred Only) and the cost of the stamp paper shall be borne by you.
3. You have been exempted for deposition of EMD for the subject tender. Therefore, you are requested to deposit Rs. 95,14,612/- (Rupees Ninety Five Lakh Fourteen Thousand Six Hundred and Twelve Only) towards Security Deposit within 10 days from the date of issue of this letter failing which, the same will be deducted as per condition Clause -1(A) on page no. GCC- 16 of the tender document.
4. You are requested to submit an irrevocable performance guarantee of 3% (three percent) of the tendered amount i.e. Rs. 57,08,767.00 (Rupees Fifty Seven Lakh Eight Thousand Seven Hundred Sixty Seven Only) in addition to other deposits mentioned in the contract towards proper performance of the contract agreement from a Nationalized Bank or any Scheduled Bank but not from co-operative or Gramin Bank within 30 days from the date of issue of this letter as per Clause 1 of GCC on page no. GCC-15 of the tender document.

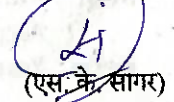
5. You are requested to comply with the provisions of contract labour (regulation and Abolition) Act 1970 and Contract labour (regulation and abolition) Central Rules 1971, Child Labour (Prohibition & Regulation) Act 1986, construction workers (Regulation of



Employment and Conditions of Service) Act 1996, Building and other Construction Workers Welfare Cess Act 1996 as specified in Clause-19 on page no. 49 of GCC, minimum wages Act 1948 as specified in Clause- 20, page no. 55 of GCC, EPF Act 1952 & ESI Act 1948 as specified in clause 20 (A) on page no. 55 & 56 of GCC of tender and rules thereof of Central and State Governments.

6. You are also directed to contact Sr. Manager (Engg.-C), Udaipur, who will arrange to hand over the site to you and take all further action for execution of work.
7. Please note that the time allowed for carrying out the work shall be 12 months **[including 2 months considered for rains of 01 monsoon season]** and same shall be reckoned from the 10th day after the date of issue of this letter.
8. All correspondence in connection with the contract should normally be addressed to the Engineer-in-Charge.
9. Please acknowledge the receipt and return the duly signed duplicate copy of this letter (enclosed) to the undersigned as a token of acceptance.
