The time schedule, Payment terms, Performance Bank Guarantee, Liquidated damages and Guarantee / Warrantee for the award no. **AAI/HY/CCTV/R_colony/2021-22/PO** dated 03.01.2022 shall be as detailed below.

1. Time Schedule: Supply, Installation, Testing and Commissioning of the items has to be completed within 90 days from the date of purchase order.

2. Payment Terms: The payment terms shall be governed by clause 13 of Section-B of E-Tender No. 2021_AAI_90368_1.

3. Performance Bank Guarantee: The bidder shall within 30 calendar days of the issue of Purchase order, shall submit performance guarantee of 3% (Three Per Cent) of the total price (excluding GST amount) to AAI in the form of an irrevocable and unconditional bank guarantee on a Nationalized / Scheduled Bank, as per Performa attached as **Annexure-VI** in the Tender document. The terms & conditions as specified in the tender shall also be applicable.

4. Liquidated Damages: In case of delay in completion of the contract, liquidated damages (L.D.) shall be levied @ 0.5% of the full value of uncompleted portion of work per week (part of week to be treated as one week) subject to a maximum of 10% of work order value. If the uncompleted work, restricts the operation of complete system then LD shall be applicable to total value of contract with approval of Competent Authority. If the bidder fails to submit the bank guarantee, 3% of Invoice amount (Exclusive of GST) shall be deducted as Security Deposit (SD). The terms & conditions as specified in the tender shall also be applicable.

5. Guarantee/ Warrantee: The warranty period of all the supplied items shall be **One year or as per OEM whichever is more**. The Warranty starts after successful completion of dispatch of material. Necessary documents towards OEM warranty shall be submitted for the applicable items mentioned in Annexure-I of the Tender document.
