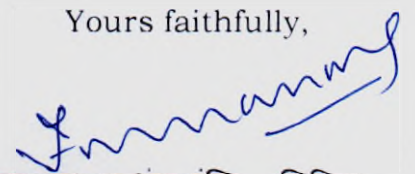

Please deposit **Rs.141692/-**(Rupees- One Lakh Forty-One Thousand Six hundred and Ninety two only) towards security deposit within 10 days from the date of issue of this letter failing which, the same will be deducted as per the condition of Clause No.1 A, on page 16 of the General Conditions of Contract.

You are directed to obtain valid Labour license as required under contract Labour (Regulation and abolition) Act 1970 and Central rules 1971, Employees Provident fund Act 1952 and Employees State Insurance Act 1948 and rules thereof Central and State Governments and produce the same to the undersigned within a period of 10 days.

You are requested to comply with the provision of Contract Labour (Regulation and Abolition) Act 1970 and Contract Labour (Regulation and Abolition) Central rules 1971 Child Labour (Prohibition & Regulation) Act 1986, Construction Workers (Regulation of Employment and Conditions of Service) Act 1996, Building and other construction workers Welfare Cess Act 1996 as specified in Clause 19 on page no.49 to 55 of GCC of tender and rules of Central and State Governments.
 6. You are also directed to contact Asst. Gen. Manager (Engg-Civil), CMD-II, AAI, Trivandrum International Airport immediately, who will arrange to hand over the site to you.
 7. Please note that the time allowed for carrying out the work shall be **03(Three) months** and same shall be reckoned from 10th day after the date of issue of this letter.
