This Agreement made on this 27th day of December Two Thousand Twenty One between Airports Authority of India as a statutory corporation incorporated under Section 18 (2) of the Airports Authority of India Act 1994 having its Head Office at Rajiv Gandhi Bhavan, Safdarjung Airport, New Delhi – 110003. Through its **Dy. General Manager (E-C), AAI, C.A. Rajkot**, (herein after referred to as "OWNER" or "AAI" which expression shall include its Administrators, Successors, Executors and Assigns) of the one part and **Balvir Singh And Sons, New Delhi** having their registered office at "D-6, 6099/8, Vasant Kunj, New Delhi" referred to as "CONTRACTOR" which expression shall include its Administrators, Successors, Executors and permitted assigns of the other part.

Whereas Airports Authority of India is desirous of getting the work of "Annual Repair & Maintenance Contract of Civil works for Non-Operational area for the year 2021-22 at C.A. Rajkot" (Herein after called the "WORK") done and had invited tenders for this work as per its tender specification.
