The contract agreement shall be executed on a non-judicial stamp paper of value Rs. 100/- (Rupees One Hundred only) and the cost of the stamp paper shall be borne by you.
3. The security deposit as per clause 1(A) on page-48 of tender document. Please deposit total Rs. 31,51,581.53/- (Rs. Thirty One Lakh Fifty One Thousand Five Hundred Eighty One and Fifty Three Paise only) (For Raipur Airport Rs. 7,98,675.29, For Vishakhapatnam Airport Rs. 8,51,614.58, For Calicut Airport Rs. 6,58,853.83 and For Bhubaneswar Airport Rs. 8,42,437.83) towards security deposit to the office of undersigned within 10 days from the date of issue of this letter, failing which the same will be deducted from your running bill as per clause 1(A) on page-48 of the contract document. Security deposit in form of BG shall be as per Appendix-I, on page no. 124-125 of contract document.

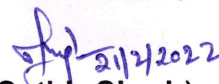

Within 30 days of issue of work award letter, you shall submit to AAI, a Performance Guarantee as per condition of clause 1 on page—47 of tender document for an amount of total Rs. 18,90,948.92 (Rs. Eighteen Lakh Ninety Thousand Nine Hundred Forty Eight and Ninety Two Paise only) to the office of undersigned in the form of Bank Guarantee as per Performa appended Appendix-XI at page no. 140-141 of Tender Document.
5. You are requested to comply with the provision of Contract labour (Regulation and Abolition) Act 1970 and contract labour (Regulation and Abolition) Central rules 1971 Child Labour (Prohibition & Regulation) Act 1986, Construction Workers (Regulation of Employment and Condition of Service) Act 1996, Building and other construction Workers. Welfare Cess Act 1996 as specified in Clause-18 to Clause-20 on page no. 81 to 88 of GCC of tender document and rules of Central and State Government.
6. You are also directed to contact Jt./Dy.General Manager(Engg.-Elect.), AAI, at respective Airport i.e. Raipur, Vishakhapatnam, Calicut and Bhubaneswar Airports, immediately who will arrange to hand over the site to you.
7. Please note that the time allowed for carrying out the work shall be **05 (Five) Years**. The effective date of contract will be from the actual date of taking over of site, on expiry of existing contract.
8. Any further correspondence in connection with the contract should normally be addressed to the Engineer-in-Charge at respective Airport i.e, Raipur, Vishakhapatnam, Calicut and Bhubaneswar Airports.
