Sir,

1. The Concession Agreement in respect of Operations, Management and Development of Guwahati International Airport has been signed between AAI and Adani Guwahati International Airport Limited (AGIAL) on 19th January 2021.
2. Clause 31.2.1 of Concession Agreement states that the Authority (AAI) shall nominate a panel of six (06) Chartered Accountancy Firms (**Panel of Chartered Accountants**) to the Concessionaire, such list to be prepared substantially in accordance with the criteria set forth in Schedule N.
3. AAI has invited an Expression of Interest (EOI) from Chartered Accountancy Firms for Empanelment of Statutory Auditor for conducting Statutory Audit of Concessionaire at Guwahati International Airport. The terms and conditions of EOI were framed in accordance with the criteria specified in Schedule N of Concession Agreement. EOI was invited through CPP Portal through an open tendering process on 14.12.2021 which was opened on 20.12.2021.
4. Twenty-Two (22) Chartered Accountants firms had submitted their bids online, out of which, 07 (Seven) firms were found eligible after scrutiny of their EOI document in accordance with prescribed procedure. The scores obtained by all the eligible firms are given as below:

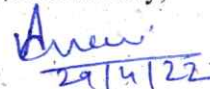
