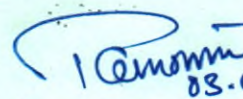
Subject: Constituting a Technical Evaluation committee to finalize the submission of tender fee & PQQ/Technical Bid for engaging medical personnel in ATM Deptt.-reg.

Service contract for engaging medical personnel for carrying out Breath Analyzer Test of ATCOs at Thiruvananthapuram airport was published through CPP portal on 24-11-2021 and the last date for bid submission was on 10th December, 2021. The e-NIT was auto extended (Corrigendum-1) with bid submission end date as 17th December, 2021, as there was only one agency participated in the e-tender. Corrigendum-2 was published for extension of the bid submission date from 17th Dec to 24th December, 2021. Vide Corrigendum-2 the bid opening date was finalized as 28th December, 2021. The PQQ/Technical bid was opened on 03-01-2022 with Shri. P. J. Paul, AGM (CNS) and Shri. Biju N., DGM (ATM) as bid openers. It was found that M/s Devis Scans Pvt. Ltd was the only agency participated in the above bid.

Prior to opening of the financial bid, the PQQ/Technical documents which includes tender fee, EMD undertaking in Annexure-A, details of Registration of the agency, details of EPIF/ESIC Registration, previous work experience, unconditional acceptance letter submitted by M/s Devi Scans Pvt. Ltd. need to be scrutinised and finalized by a committee constituting of 3 members, with one Officer from the Finance Deptt. Hence, it is submitted that a three member committee consisting of the following members may be constituted for finalizing the PQQ/Technical bid and examining the submission of tender fee for engaging medical personnel for carrying out Breath Analyzer Test in ATM Department.
